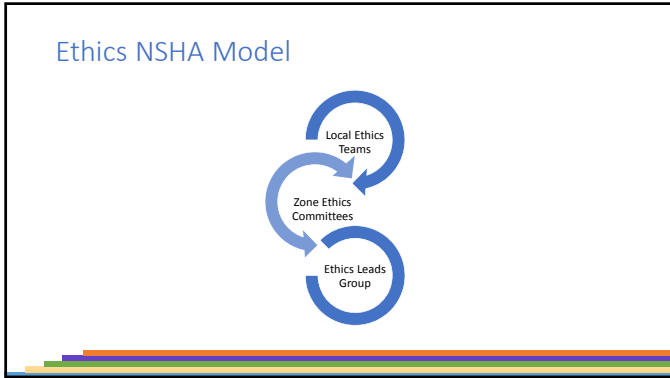

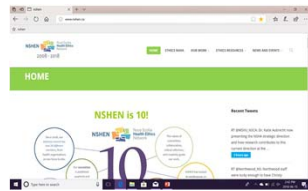

### Case – Retrospective Review

- The ethics committee has been asked to review a situation where the patient, Anya, was admitted through the ED from a long term care facility. She was diagnosed with pneumonia. Anya's son, Shawn, accompanied her and participated in making decisions about not to pursue active treatment, opting for palliation instead.
- Just before Anya died, another child, Trevor, came forward and said that they had been appointed Anya's delegate in her personal directive. Trevor asserted that Anya would have chosen to pursue all possible curative measures before accepting palliative care.
- The team was unsure how to handle the situation, and Anya died a few hours after Trevor arrived. They are still experiencing distress resulting from this case and are seeking feedback from the ethics committee.
