

## **Ethical Challenges Around Substitute Decision Making in Clinical Practice**

## **Questions:**

- In your opinion, what is the biggest challenge associated with substitute decision making in health care?
- Dr. Gradstein talks about biases as a challenge in substitute decision making. She suggests ways of framing questions to substitute decision makers that put the patient's values in focus.
  - Can you think of other strategies health care providers can use to support decision making based on the patient's values and to avoid situations where decisions may be driven by the substitute decision maker (SDM)'s values or wishes rather than those of the patient?
- Sometimes patients make health care decisions for themselves that health care providers disagree with. This may also be the case in substitute decision making.
  - From a health care provider's perspective, do you think it makes a difference to how you would react if the challenging decision is made by an SDM? Why/why not?
- What would you do if an SDM was not acting in what you understand as your patient's best interest?
- Challenges related to substitute decision making in health care often arise due to disagreement between family members and the SDM around values relevant to health care decisions for the patient.
  - Discuss different approaches that a health care team can take to navigate such situations with the SDM and family.
  - O When might you contact ethics support for an ethics consultation?
- Dr. Gradstein talks about fluctuating capacity as being a particular challenge.

- What can health care providers, substitute decisions makers and patients do to prepare for such situations?
- Based on your experience, what are some of the ways that health care providers can support SDMs in their role?
- People sometimes change their minds. What a patient once said about what they would or wouldn't want may not apply in a new context.
  - o How would you address this uncertainty as a health care provider and/or as an SDM?
- Discuss how personal directives and other forms of advance care planning may help the substitute decision making process.
