Ethical Challenges in Substitute Decision Making

The following discussion questions are provided as an additional educational tool to accompany this fireside chat video. Questions:

- In your opinion, what is the biggest challenge associated with being a substitute decision maker (SDM)?
- Gail highlights the importance of establishing a good working relationship around decision making for patients who can't make health decisions for themselves.
 - O What are some of the things that SDMs and health care team members can do to promote communication and a good working relationship around the goals of care for the patient?
- Gail talks about the importance of having support among other family members when acting as an SDM.
 - O Who else might provide support for people in the SDM role?
- Substitute decision-making should reflect the patient's wishes and values.
 - o What do SDMs do if the patient's wishes are not known?
 - O Can you give some examples of what it means to make decisions based on someone's values?
 - O How can families and health care teams ensure that the decisions that are made for the patient reflect the patient's best interest if the patient's wishes and values about the decision are unknown?
- What can SDMs do to prevent their own values and beliefs about health care from influencing the
 decisions they are making for someone else?
- What can the health care system and health care teams do to better support people in the role of SDM?
- People sometimes change their minds. What a patient once said they about what they would or wouldn't want may not apply in a new situation.
 - o If you were to make health care decisions for someone else, how would you address this uncertainty?
- How can personal directives help the substitute decision making process?
